



ICEWORKS PUBLIC SKATE GUIDELINES

As per the Pennsylvania Department of Health, IceWorks will now be operating our facility at 75% of our total capacity.



Face Covering Policy

1. All customers must have on a proper face covering to enter the building. Customers who do not have a proper face covering will not be able to access our building.
2. All customers must have on a proper face covering to enter the ice surface. You will not be permitted on the ice without a proper face covering. The face covering must always be kept on---when on and off the ice.
3. Face coverings may only be removed when eating or drinking in the restaurant areas and must be immediately put back on when finished.
4. Please view all Pennsylvania Department of Health & CDC information regarding proper face coverings before coming to IceWorks.

Skate Rentals

1. IceWorks is encouraging all skaters to bring their own skates. If that is not possible, skate rentals at IceWorks will be available upon request.
2. All skate rentals are sprayed with a disinfectant after each use.

Skating

1. Player benches and hockey/score box is prohibited to all customers.

FACE COVERINGS ARE MANDATORY AND ACCESS TO THE ICE WILL BE PROHIBITED IF YOU ARE NOT WEARING A PROPER FACE COVERING.

IF YOU TEST POSITIVE FOR CORONAVIRUS WITHIN SEVEN DAYS OF YOUR VISIT TO ONE OF OUR PUBLIC SKATING SESSIONS, YOU MUST CALL ICEWORKS TO REPORT IT. WE WILL NOT ASK FOR YOUR NAME, JUST THE DATE AND TIME THAT YOU ATTENDED OUR PUBLIC SKATE SESSION.
